**SHARING YOUR INFORMATION**

If your child is successful and is awarded a badge, their name might be disclosed to the public. The BBC will share the personal data with a third party (Print.UK.com) to process the Blue Peter badge card which is needed (together with the badge) to gain free entry into Blue Peter Badge Attractions. Print.UK.com will store the data in accordance with the BBC's instructions and will delete it once the Badge Card has been produced.
